- 6) The Governing Body of the college will be constituted at the earliest as per St. 3(GB) of Burdwan University Statutes relating to Constitution, Power and Functions of the Governing Body of affiliated colleges other than Govt. Colleges. Pending that, the college will be run by an ad-hoc G.B. duly approved by the University.
- 7) The fees structure shall be as per norms of the University and Government of West Bengal.
